Important Vaccination Update

Ontario Makes COVID-19 Vaccination Policies Mandatory for High Risk Settings

In response to evolving data around the transmissibility of the Delta variant, and based on the recent experiences of other jurisdictions, the government, in consultation with the Chief Medical Officer of Health, is taking action to increase protection for our most vulnerable, including frail seniors, immunocompromised individuals and young children who are not yet eligible for vaccination. This includes making COVID-19 vaccination policies mandatory in high-risk settings, pausing the province's exit from the Roadmap to Reopen, and providing third doses of the COVID-19 vaccine to vulnerable populations. If applicable, you may receive a phone call, asking for consent for the vaccine for your loved one.

To protect vulnerable patients and staff in settings where the risk of contracting and transmitting COVID-19 and the Delta variant is higher, the Chief Medical Officer of Health has issued a directive mandating hospitals and home and community care service providers to have a COVID-19 vaccination policy for employees, staff, contractors, students, and volunteers, and for ambulance services to have a COVID-19 vaccination policy for paramedics. West Park Health's centre's vaccination policy must be effective in August, and we are in compliance with the government's requirements. At minimum we require these individuals to provide proof of one of three things:

- Full vaccination against COVID-19;
- A medical reason for not being vaccinated against COVID-19; or
- Completion of a COVID-19 vaccination educational session.

West Park's Vaccination Rate

We are pleased to announce that we are compliant with Ontario's vaccination mandate, and have fully implemented our Home's policy.

To date, these are our Home's vaccination numbers:

Residents First Dose – 94%

Second Dose – 91% Refused – 4 people

Staff Members

First Dose – 93% Second Dose – 89 % Refused – 6 people

Second doses are scheduled for residents and staff members who are partially vaccinated.

For staff members refusing the COVID-19 Vaccine, have either provided a medical reason for not being vaccinated against COVID-19, or completed a COVID-19 educational session.
